A Blue Print for A Transitional Government!

In the coming days, weeks or months the forces that are fighting the Ethiopian Government, Amhara Regional State and Prosperity Party will form a transitional government.

The traditional government will take upon itself the task of setting up a timetable where by all nations and nationalities now comprising Ethiopia will decide the destiny for themselves whether to form a union of nations and nationalities under one governance or create their independent states by undertaking a free and fair referendum.

The forces that make up the transitional government must demand the dissolution of all political, military, financial institutions of the Ethiopian Government, Amhara Regional Government, Militias and political organisations and distribute the resources confiscated among themselves in a direct proportionality as per the war damages they sustained.

The transitional government should demand the immediate handover of Eritrean political and military leaders to face charges for war crimes, ethnic cleansing, war crimes against humanity, rapes, and genocide against the people of Tigray, Oromo, Benishangul-Gumuz, Kemant, Agew, Afar and other affected ethnic groups. Eritrea must return all assets looted from Ethiopia particularly Tigray. Eritrea must also pay a compensation for the war and genocidal crimes it has committed.

There shall be no inclusion for the Amhara political parties to be part of the transitional government as there has been no Amhara political party nor organisation that has stood firm as a resistance against genocide that is committed by the Ethiopian Government or Amhara Regional State Special Forces and Fano Militia.

Genocidaires should not be part of transitional government. The Abiy's Government, Prosperity Party and Amhara Regional State Government and Amhara Political parties who involve in genocide, rapes, war crimes, crimes against humanity, ethnic cleansing, looting and destruction of properties should be brought in to justice in order to establish lasting peace and bring in closures to victims of genocide, ethnic cleansing, rape and sexual violence.

Participation of an Amhara group for the sake of representation of all people living in Ethiopia undermines the notion that this transitional government is a response to Amhara hegemony that can no longer be trusted. The Germans were denied **plenipotentiary statues** and participation in the European Union, a standing army and a nuclear arsenal. Furthermore, they lost contested land to France.

If any Amhara genocidaire group is allowed to participate in the transitional government, the group will be obstacle to lasting peace. Furthermore, it is politically unpalatable to work with the genocidaires and the enemy of TDF, Oromo, Agew, Kemant, Benishangul-Gumuz, Sidama, Somali, Gambella and Afar liberations fronts.

In fairness, the Amhara people's democratic and human rights has to be respected during and after the transitional government period of power comes to an end. In the end, the Amharas have to decided their destiny freely and fairly just like the other nations or nationalities now living under Ethiopia. It should be noted clearly that any political party or group should have no place to participate in the transitional government. Other oppressed nations and nationalities who did not actively fight to bring down the genocidal government ought to be included, and their rights have to be fully respected to decide their future in the formation of the transitional government.

Hunting Tigrayans and forcing them in to concentration camps is too awful to erase from memory to consider giving the Abiy's Government, Amhara political parties and Prosperity Party a place in transitional government. Neither the Amhara leaders nor their followers have opposed the killings, disappearances, etnic cleansing, persecutions and incarcerations of Tigrayans in concentration camps. This will be too much to contemplate to give concessions and political platforms for hate speech preachers and genocide leaders. Bringing the perpetrators to justice should be the main priority for the transitional government to ensue reconciliation and peaceful coexsitence amongst all ethnic groups in Ethiopia.
